I understand and agree to the following terms of Field Education:

I am responsible for maintaining communication with the Field Education Department in order to secure a field placement. If I do not hear from the Field Education department by June 1st, it is my responsibility to contact Nancy Urcinas at nancy.urcinas@uconn.edu

I must check my UConn email address regularly.

I will complete 560 hours of field placement this academic year. **If I choose 20 hours I will be considered a May Grad or if I choose 15 hours I will be considered an August Grad**

I must be in the agency during **its prime operating hours** (weekdays) during the time the field instructor and/or task supervisor is present.

I must have a plan in place to permit me to complete my field placement hours as stated above (e.g., using flex time, educational leave, vacation time).

An agency may require a criminal background check & health documentation to be completed.

I may have to cover the cost for these documents if not covered by the agency.

I will follow the SSW calendar **or** may need to follow the agency's calendar (e.g., many school settings). **I may not follow both.**

I **must** attend the four (4) scheduled Field Advising Seminars during the academic year. (Check Academic/Field Education Calendar for dates on <http://ssw.uconn.edu/field-education-2>)

I may need to travel up to forty-five (45) minutes for an appropriate field placement.

I must attend field during my regularly scheduled time as set up with my field instructor and I must notify my field instructor in a timely manner if I cannot make it to field placement.

I must be available by UConn email or phone during the placement process.
